

Grant Agreement
Between
The Partnership for Transparency Fund
And
The Ayauskam

1. **The Ayauskam**, hereafter called the Grant Applicant, has requested financial support of the Partnership for Transparency Fund (PTF) to implement a program for '**Checking Corruption of Health Sector in 10 Panchayats of Khariar under Nuapada District of Orissa**' hereafter called "the Project". The Project will commence on **15th June, 2009**. The project will be governed by this grant agreement including the attachments thereof.

2. Grant Applicant has submitted the attached Project Proposal dated **11th May, 2009** which includes background information on **The Ayauskam**, objectives for the Project, proposed activities, deliverables, monitoring and evaluation arrangements, Project team details, time frame for implementation and a detailed breakdown of costs.

3. On the basis of this information, PTF has approved a grant of **US\$21,000.00 (Twenty-One Thousand US dollars)** to be disbursed in three tranches each for the purposes spelled out in the attached documents. The tranches will be disbursed as follows:

- First tranche of **US\$6300.00 (Six thousand and Three hundred US dollars)** to be disbursed on signature of this Grant Agreement.
- Second tranche of **US\$10500.00 (Ten thousand and Five hundred US dollars)** to be disbursed once the first tranche has been used and **upon completion of baseline survey and formation of vigilance committees, selection of community advocates and accreditation by Credibility Alliance, India** by the Grant Applicant and PTF finds it satisfactory.
- Third tranche of **US\$4200.00 (Four thousand and Two hundred US dollars)** to be disbursed **upon completion of the project and receipt of a satisfactory completion report** from Grant Applicant that describes and assesses the Project achievements including preliminary assessment of impact..

The uses of the PTF funds will be for the budget items listed in the attached Project Proposal.

4. The PTF Grant will be made available to **The Ayauskam** on the following conditions:

- (a) The grant will be used only for the purposes described in the attached Project Proposal. Any material changes in the use of Project funds or Project design shall be made only with the agreement of the PTF.
- (b) Any funds remaining at the end of the Project shall be returned by the Grant Applicant to the PTF.
- (c) The Grant Applicant shall keep a record of all expenditures incurred under the Project and will provide PTF a full certified accounting of these expenditures, with relevant documentation, on completion of the Project, or no later than **30th June, 2010**. These expenditures will also be subject to the regular auditing requirements of the Grant Applicant



and the Grant Applicant will furnish the PTF with a copy of the relevant audit if so requested.


- (d) The Grant Applicant will make brief quarterly reports on the implementation of the Project accompanied by a statement of expenditure showing the use of PTF funds and, on Project completion, a full detailed final report summarising the implementation of the Project and its outcome and assessing the impact of the Project on Increasing transparency and accountability in **10 Panchayats of Khariar Block in Nuapada district of Orissa**, its likely sustainability and the lessons learned, together with a certified final itemised statement of expenditure. The latter report will be sent within two months of the completion of the Project, together with a copy of any other reports prepared under the Project.
- (e) Following Project completion, the PTF may make its own independent ex post evaluation of the implementation, outcome and impact of the Project. The Grant Applicant will furnish the person appointed to undertake this task all possible assistance and access to all relevant documents.
- (f) The Grant Applicant will post this agreement, the Project Proposal, the final Project report, and the statement of expenditures on its website and/or the PTF Website.

5. The Grant Applicant will be responsible for securing all necessary government approvals of the grant, if any, and any necessary government filings. The Grant Applicant will be responsible for paying any tax liability arising from the grant.


